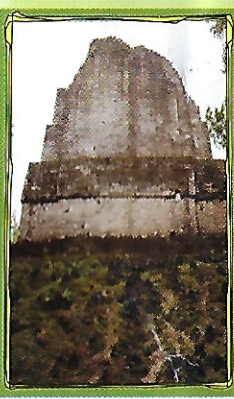


Templo III

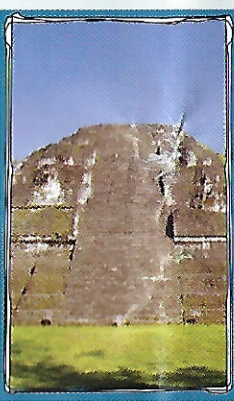


Templo I

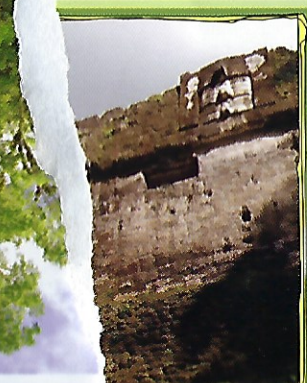

GREAT PYRAMID PLAZA (or Lost World) Here we have the oldest building in Tikal called the Great Pyramid. The Lost World name comes out of its different architecture from the rest of the buildings in Tikal.

Templo IV

TEMPLE IV Also called The Two-headed Snake Temple. It's the tallest temple in Tikal and in all Mesoamerica. Built in 740 AD it's 70.0 m tall. The visitor can climb-up to the top and enjoy a magnificent view.

If you arranged your own air transfers to the island, please advise us of your arrival time, so we can have someone meet you. The cost of the ground transfer is \$5.00 per person, round trip.

All activities are arranged once at the resort, through our on-site dive center. The only exception to this is fishing or dive courses. If you would like to schedule either of these, please contact our reservations office.

During our high and low season, cancellations received greater than 90 days prior to arrival will receive a full refund. Cancellations received 60 to 90 days prior to arrival will forfeit 25% of deposit. Cancellations received within 45 to 60 days of arrival will forfeit 50% of deposit and payment. Any cancellation received within 45 days of arrival will result in forfeiture of all monies received. All final balances for travel during high or low season are processed automatically 45 days prior to arrival. We recommend trip cancellation insurance as there are no refunds for delays due to airline or weather, including a hurricane occurrence.

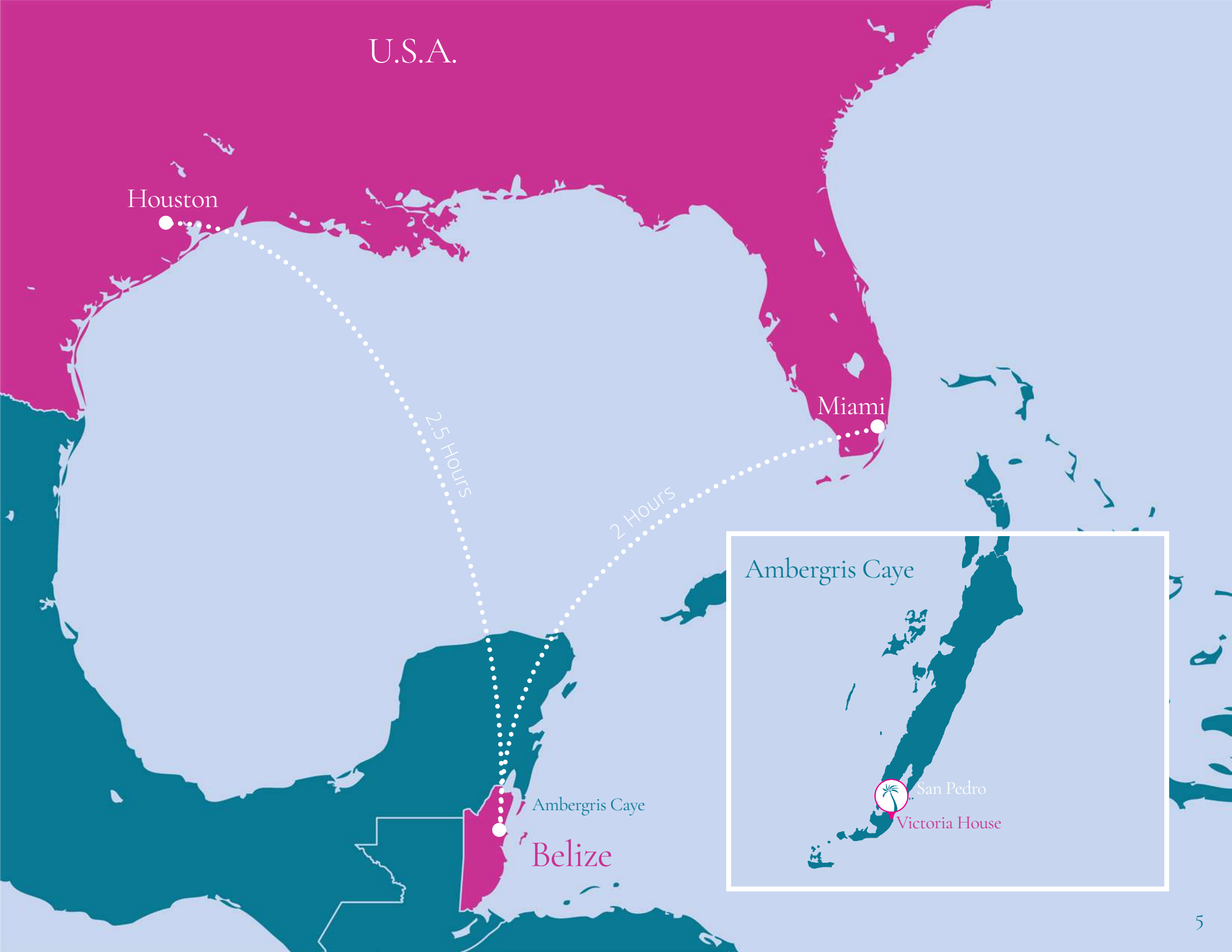
For guests who book their domestic flights through our reservations office, the round trip ground transfer charge is included in the booking.

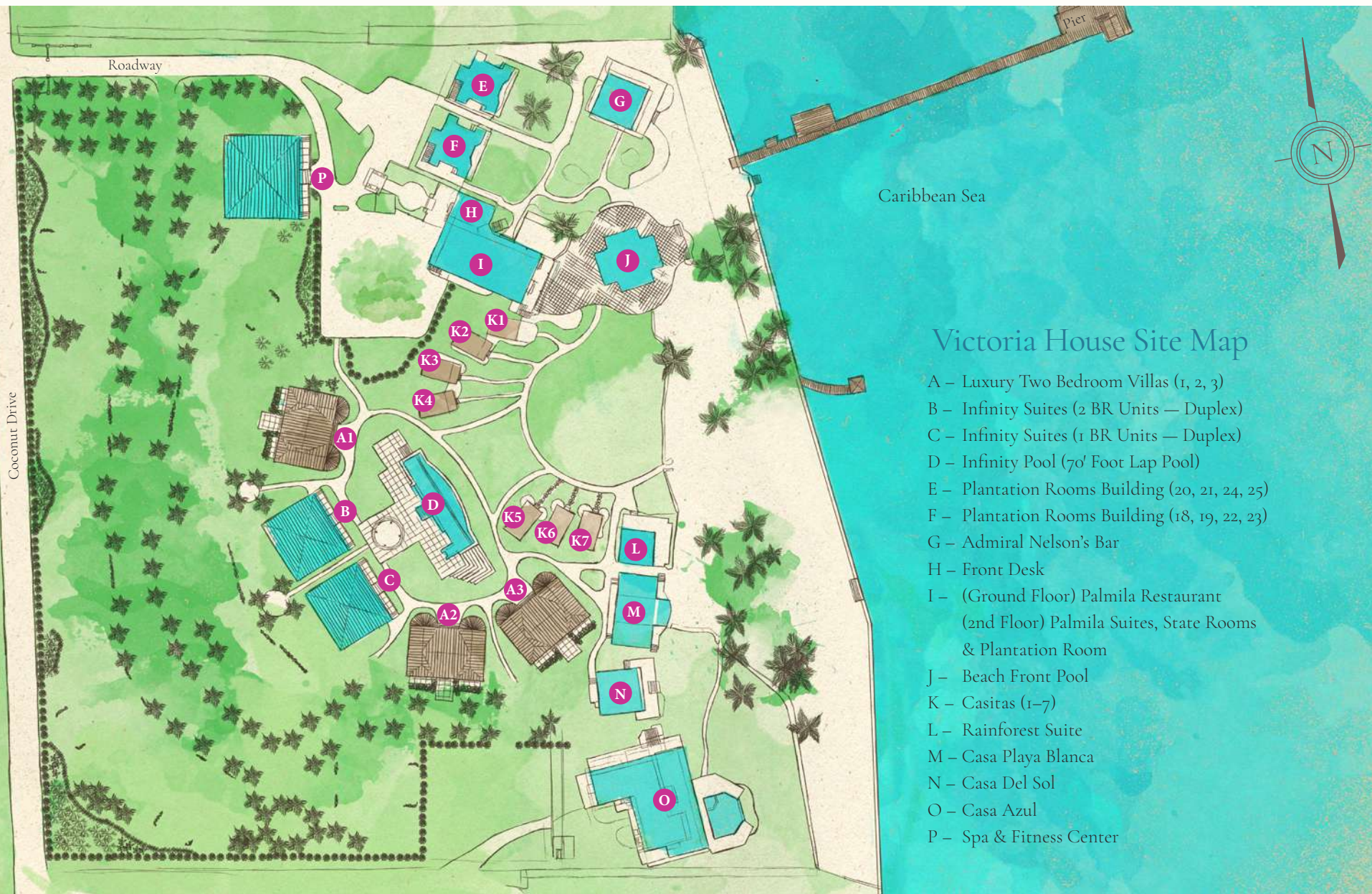
